1. WHO WE ARE

2. THE COMPETITION

3. **HOW TO ENTER**

- 3.1 The competition will run from 00:01 on 18th October 2021 (**Opening Date**) to 23:59 on 26th November 2021 (**Closing Date**) inclusive.
- 3.2 All competition entries must be received by us by no later than 23:59 on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
- 3.3 To enter the competition please fill in and submit the online entry form provided on https://www.tecniplast.it/uk/ukcompetition.html by the Closing Date.
- 3.4 No purchase is necessary in order to enter this competition and there is no charge to register for use of the website.

3.5 We will **not** accept:

- 3.5.1 responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or

4. **ELIGIBILITY**
